
## What Are The Benefits Of DSI Gaming Compliance Software?

#### How is this different from our existing ERP (Enterprise Resource Planning) software?

While ERP systems are absolutely necessary for a manufacturing organization to work effectively, the fact is that Over-the-Counter ERP applications don't include modules specific to the casino gaming manufacturing industry. Our expertise in ERP Software Implementation, Supply Chain Management Systems, Bill of Materials, WIP (Work-in-Process), Gaming Compliance and computer/networking technical support experience make us an excellent Strategic Partner to help you implement and/or integrate with your existing environment.

#### Can we integrate this Gaming Compliance software with our existing ERP system?

Yes, we have extensive experience integrating our application with existing ERP systems such as SAP, Oracle, Pronto, Kewill, Mapics, MAS90. By using a "Highly Normalized Database Structure" we are able to create and utilize a functional dependency on existing Part/Program/Model Numbers and other key ERP database elements to integrate directly with your existing ERP system.

#### Do you require direct access to our existing ERP system?

Our goal is to integrate with your existing system, if necessary, without having direct access to your existing ERP database. We are only interested in <u>Reading</u> your existing data. We call this non-intrusive process "**Passive Database Integration**". Our goal is to get this application up and running as quickly and efficiently as possible without disturbing the integrity and availability of your existing applications.

#### Will our IT staff have to be directly involved with the implementation?

We normally like to meet with the IT staff to ensure that this application will not affect their current processes or corporate security policies. This application is web based and very easy to access from the Corporate Intranet. If global visibility outside of the Local Area Network is a requirement, it will be necessary to get your IT department involved to ensure that existing corporate security policy requirements are properly addressed.

#### Cost and Pricing?

Because this is considered Semi-Customized software, we cannot provide a fixed-price cost without first meeting with your team and discussing your requirements. Some organizations may require immediate direct ERP integration while others may want to quickly implement with a stand-alone system. Pricing is based on specific module implementation and the amount of time required for us to integrate the modules into your existing organizational infrastructure. Hardware and Software costs are directly related to the expected number of users. After meeting with your organization and gathering requirements we will provide an affordable detailed cost proposal.

## FREQUENTLY ASKED QUESTIONS (Continued)

Is this considered Customized Software?

Yes. Because there are ordinarily specific organizational requirements to integrate or make our solution compatible with your existing processes and possible ERP system integration, organizational customization is almost always required to implement the various gaming compliance software modules.

I thought the purpose of an ERP system was to consolidate all of our enterprise business processes into one system and/or database. Isn't this counter-productive to that concept?

We consider this system to be a modular unit that allows you to add a major functionality component specific to Gaming Manufacturers that is not normally included in over-the-counter ERP systems. We designed this application to (1) integrate directly into your existing ERP system via "Passive Database Integration", or (2) run as a standalone system with eventual organizational ERP integration. The definitive consideration here is that regardless of what ERP system you use currently or in the future, our technical team will design and implement this modular solution with eventual ERP integration being the ultimate goal.

Is Confidential and Financial Data Secure over these Web Applications?

Yes. For transactions that require the storage and retrieval of financial and confidential transactions over the intranet/internet, we utilize 128-Bit SSL (Secure Sockets Layer). The Secure Sockets Layer protects data transferred over the internet/intranet using encryption enabled by our server's 128-Bit SSL Data Encryption Certificate. An SSL Certificate contains a public key and a private key. A public key is used to encrypt information and a private key is used to decipher it. When a browser points to a secured domain, an SSL handshake authenticates the server and the client and establishes an encryption method and a unique session key. They can begin a secure session that protects data and messaging privacy integrity.
